Honorable Mayors and Councilmembers:

I am writing to ask for your support for re-appointment to the Housing Endowment and Regional Trust (HEART) Board of Directors. It has been an honor to contribute to the great work HEART has achieved in San Mateo County over the last five years, and I would deeply appreciate the opportunity to continue in my role.

Since joining the HEART Board I have taken an active role in Board duties. In addition to attending regular Board meetings, I served on the Strategic Review Subcommittee which was charged with identifying innovative ways HEART could increase funding for the construction and preservation of affordable housing in our communities. I am also the Chair of HEART's newly-formed Legislative Action Committee which will advocate for housing legislation impacting HEART's work to create more affordable housing opportunities in San Mateo County.

Increasing affordable housing for our low and middle-income residents continues to be a top priority of mine and I am proud that affordable housing is a San Carlos City Council strategic priority. In June, our Council approved a \$12.8 million loan to construct a 100% affordable housing project in partnership with Eden Housing and HIP Housing. At the same meeting we agreed to purchase two properties adjacent to El Camino Real for \$12 million that will be used to build another 100% affordable housing project in the range of 90 units. These are major investments and are evidence of our strong commitment to affordable housing in our community.

HEART continues to do great work throughout the County, including: providing funding for Kiku Crossing in San Mateo, offering free ADU plans available for anyone to download from HEART's website, contributing funding for the development of much-needed teacher housing in Pacifica, and offering workshops and loans for first-time homebuyers. HEART is also doing innovative work to establish a Middle-Income Housing Bond Program and to acquire small apartment buildings to stop the displacement of low-income residents.

I strongly believe in HEART's mission. I would appreciate the opportunity to continue my service on HEART's Board of Directors and respectfully ask for your support.
