## Hi Camille,

If vegetation removal is associated with the Project, then the required bio surveys (MMs BIO-2a-2d) would need to be completed prior to the start of disturbance. Also, please keep in mind that we are within the nesting bird season; therefore, a nest survey should be done to ensure there isn't a violation of the Migratory Bird Treaty Act or Fish and Game Code.

However, if this is not necessarily associated with the Project and is more of a fire hazard prevention measure, then I guess that would all depend on if the County has any exemptions specific to fire prevention efforts. I would have to defer to you on this.
