INTRODUCTION SUMMARY

Gross earnings for the month ending December 31, 2021 were .90%. Gross earnings for the quarter ending December 2021 were .958%. Current average maturity of the portfolio 1.60 years with an average duration of 1.56 years. The current Par Value of the pool is \$6.936 Billion. The largest non-government aggregate position is currently Toyota 1.10%. The portfolio continues to hold no derivative products.

The estimated earnings for FY 2021-22 is .98%.

The San Mateo County Pool complies with Government Code Section 53646, which requires the ability to meet its expenditure requirements for the next six months.

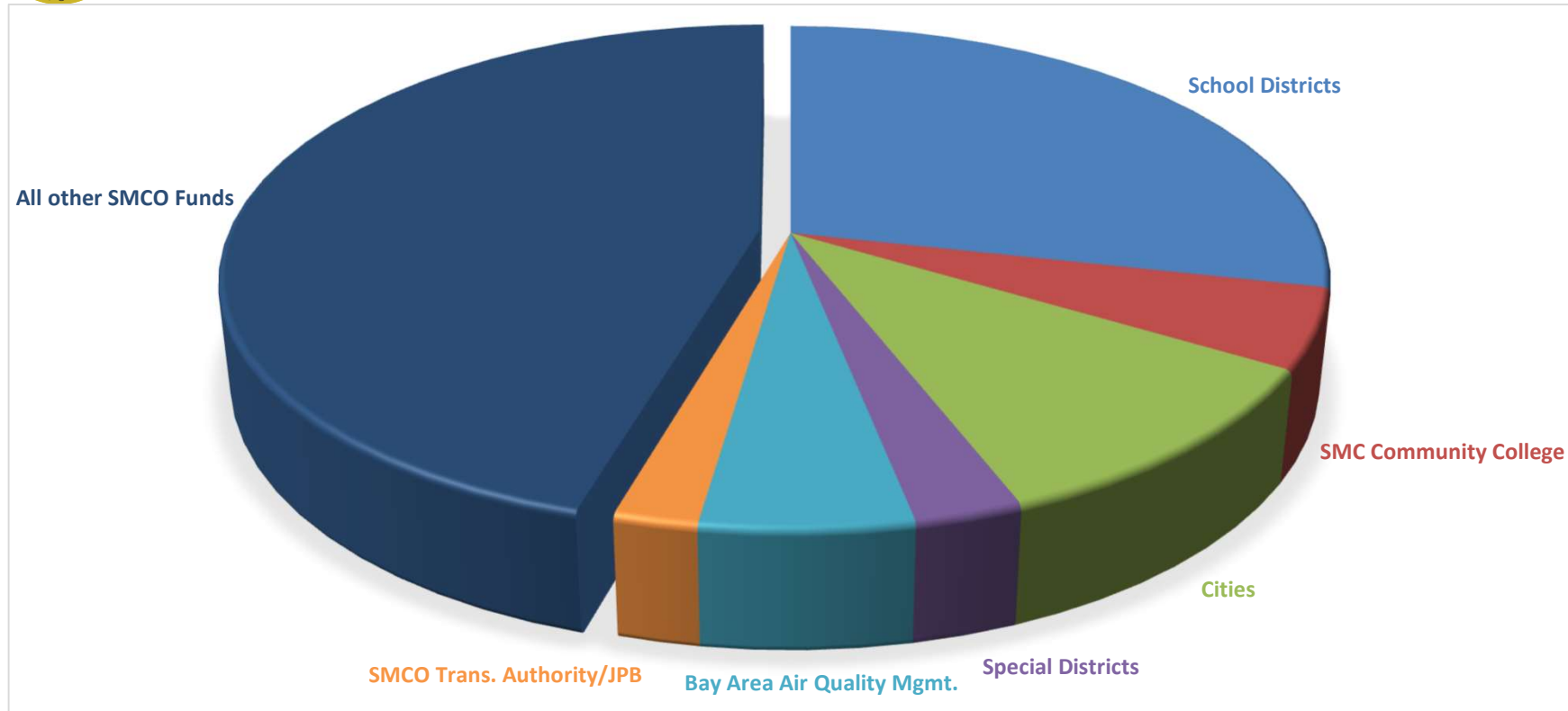
