
Population by Age Group County: San Mateo

Older Adults typically see their income reduce by half as they age from their 50s to their 80s. Older adults who own their homes are often house rich but income poor.


















Protection - Adult Protective Services (APS)

Investigates reports of abuse of older and dependent adults

Effective 1/1/2022 older adult = 60+ Dependent
adult =

18 - 59 years
old





Common Myths

Take control of clients (i.e., 5150, place clients)

Force clients out of their homes

Make medical diagnoses

Share confidential information without legal authority

Get involved with or solve family disputes

Deliver meals

Enter the home without permission

Force people to accept services





Protection – Elder & Dependent Adult Protection Team

Streamline and facilitate investigation and prosecution of older and dependent adult abuse

Coordinate supportive services to victims

Protection-Public Guardian/Conservatorship

General Conservatorship:

Frail elderly and disabled who are unable to provide for their own health care, food, clothing, shelter, or manage their own finances.

<u>Limited</u> <u>Conservatorship:</u>

Adults with developmental disabilities who cannot fully care for themselves or their finances. No need for higher levels of care.





Protection-Public Guardian/Conservatorship

Conservator of Person:

Responsible for making sure that the conservatee has proper food, clothing, shelter, and health care.

Conservator of Estate:

Handles financial matters—like paying bills and collecting a person's income, if the judge decides the conservatee cannot.





Protection-Lanterman, Petris & Short Conservatorship (LPS)

- Adults with serious mental health illnesses who need special care
- Usually require very restrictive living arrangements
- Need extensive mental health treatment
- Last for 1 year; Need reappointment by court



Protection-Public Administrator

Investigates the estates and administers the estate of those who die without a will or a person willing to act as administrator

Duties include:

- Burial arrangements
- Protect property from waste, loss or theft
- Investigate to discover assets
- Locate heirs
- Liquidate assets as appropriate





Support - Linkages



Case management & information / assistance to frail, at risk older adults and adults with functional impairments who are 18 and older.

Coordinate community resources to help clients remain independent in the community.





Support – In-Home Supportive Services (IHSS)

- Must be aged, living with a disability, and/or blind
- Disability lasting longer than 12 months/certified by Health Care Professional
- Minor with disability

- Medi-Cal
- Live in San Mateo County
- Require assistance with ADL, IADL, and be at risk of out of home placement





Support – IHSS Public Authority

Caregiver Registry:

Outreach, enroll and maintain caregivers

Payroll:

Provides employment support for caregivers

Training:

Employer and employee expectations, first aid, complex behaviors and grief





Support – Enhanced Case Management

Comprehensive case management services for medically complex adults and older adults

- Medi-Cal benefit
- Pilot with Health
 Plan of San Mateo
- Goal = avoid institutionalization
