  - SMC Medical Center: ob/gyn services for more than 6,450 women and 50%+ are White/Latina
  - Types of services range from general gynecological health to all care related to pregnancy
  - Programs: Medi-Cal and Family Planning Access Care and Treatment
  - Committed to reproductive choice. 50 abortions per year (6500). Demand has lowered with contraceptive literacy.
  - Critical partnership with Planned Parenthood
  - Following the action plan from Future of Abortion Council

- Safety at the clinics: volunteers to sign up as escorts? Under the buffer zone action point.
- CSW can serve as advocates with what the County action plan could be. City Council meetings, social media. Connect with youth who can join in advocating.
- Five bills in CA summary (refer to meeting materials)
- What the CSW can do is direct staff to work on the issues or bills you feel need to be prioritized.
- The CSW can support issues rather than actually bills that Peggy and Linda can incorporate into their action. We have a small group tonight; will encourage us to have full discussion in June. Examples of issues are: 1. Protection of medical workers who provide services to non-residential patients. 2. Protection of people seeking medical services who come from other states. 3. Capacity building for more safe care.
- The CSW asks that this action is agendized for the June CSW meeting.
- Discussion results: the present CSW is supportive of the Board of Supervisors' Resolution and future action plan. **Request** to 1. take action on the support of the BOS resolution at the June CSW meeting and 2. To prioritize issues and come to consensus of those issues for the County's action plan at the June CSW meeting.
- REQUEST from present Commissioner: June meeting is important to read/study meeting materials and attend for discussion and action.
