



My name is Christian Cagigal, writing on behalf of myself and my father, Julio Cagigal. My family immigrated to California in 1958, escaping death and fascism in Spain. My grandmother, aunt and father, worked hard and in 1964 bought our home at 620 Manila Way back when immigrants weren't welcomed yet. My father Julio fought in the Vietnam War and came home to Broadmoor Village with mental conditions inflicted upon him by the trauma he experienced. He eventually met and married my mother Elsa. I was born in 1975 and was raised in that same house, where I still reside with my father. And through all these ups and downs Broadmoor Village has been our safe place, our oasis, our home, well looked after by our Broadmoor Police Department.

Historically, Daly City has successfully encroached on our independent enclave, taking more and more from us, which has benefited Daly City more than it has benefited Broadmoor residents. Dismantling our police department is only another attempt by Daly City to undue Broadmoor further.

Yes, we are aware of the problems Broadmoor PD have and we'd like our Broadmoor PD cleaned up! But, we are also aware of the problems the DCPD have as well, as they are not as well staffed as they should be. So, the result will eventually be: higher taxes for Broadmoor Residents, to receive services from someone else's police department that won't be able to respond to us in a timely manner. Getting rid of Broadmoor PD entirely is not the answer. It won't make things better for Daly City Police nor Broadmoor Residence. We want to keep our Broadmoor Police District.
