We have over twenty years of home ownership in Broadmoor Village, and have been well served by the Broadmoor Police Department throughout our life here, the place we call home.

We are firm believers that the residents of Broadmoor and the Broadmoor Police Commission should be the sole decision makers of whom protects our District.

The current climate on the local and national level of the perception of public safety does not now, or ever, justify the removal of a dedicated and committed to the Community police force.

The data reflected in your report is not accurate regarding the number of residents, the number of calls for service, and the cost per call.
