DVC ANNUAL DATA REPORT (ADR) OUTLINE - DRAFT

The idea of the ADR is to tell a story of Intimate Partner Violence in San Mateo County. We tell this from the perspective of the Victim/ Survivor, from the Person Doing Harm and from a look at the toll Intimate Partner Violence (IPV) takes such as in deaths related to IPV and Crimes related to a history of growing up in a high conflict/ violent family. This report is not an aggregation of data so much as a way to take the vital information available from many sources to understand and explain the scope and impact of IPV in the county each year. Data will be pulled from many sources.

As much as possible data will be examined in the following ways:

- How do current stats compare to previous years?
- How do current stats compare to overall population numbers?
- What can we learn by looking at current stats together for example, # of 911 calls, # of CORA hotline calls, and # of police reports of DV as seen side by side.
- What do we know of outcomes and impact?

The overall topics of the report include

- Victim Survivors
- Persons Doing Harm
- > The Toll of IPV in the County
- Prevention Efforts and Successes

VICTIM SURVIVORS

UNDERSTANDING THE ISSUE BY THE NUMBERS

How do Victims/ Survivors seek help. This Data includes but not limited to

- Demographic data on Victim Survivors
 - Race, ethnicity, LGBTQIA+, income, geography
- Number of children involved in homes where IPA/ IPV possibly occuring
- Counts of entrance into services sought Hotline calls, ERP calls, types of referrals and where these are from.

WHAT DO WE KNOW ABOUT THE ISSUE?

This section talks about the wide range of abuse and what we know about the ways abuse may be perpetrated. This data includes but not limited to

- Range of weapons used
- Range of non physical abuse reported
- Intersection with Substance Abuse if data is available

WHAT SERVICES ARE DESIRED BY VICTIM/ SURVIVORS

What do we know about what individuals seek as they experience IPA? They may not receive these services due to capacity or their ability to follow through, but what are they asking for?

- EPR CALLS what services are requested?
- CORA Hotline calls what services are requested
- Other points of contact what services are requested?

WHAT VICTIM / SURVIVOR SERVICES WERE UTILIZED?

Data on what services were utilized

- Mental Health adults, children
- Housing and emergency shelter/ safe house use. Other shelter use
- Legal services

AND WHAT DO WE KNOW ABOUT OUTCOMES?

- Mental Health adults, children any outcome data
- Housing individuals who receive housing, \$\$ of money provided for supports, use of safe houses, outcomes gaining permanent residence (having income that covers needs)
- Legal services Restraining orders, removal of guns, custody etc... outcome stats?
- Recantation information what can we know about this and why it occurs?

In this section we look at the ways that PDH are identified and move thorough the system. This Data includes but not limited to:

- Demographic data on PDH
 - Race, ethnicity, LGBTQIA+, income, geography
- Ways individuals are identified

What do we know about what PDH experience as they move through a legal / reparative process?

- Ways we can share successes narratives, data of improving trends

<u>Challenges with the data</u>: Many people may not want to label DV. Many people may not want to share actual addresses. Defining what Success means in court? That many services are for low income and that this means that services provided to middle- or upper-income households likely missed or very underreported. Other challenges to be identified.

<u>Wide Range of Data Sources</u> including, DA, Court, Legal Services Legal Aid Society, Bay Area Legal, Family Justice Center), Sitike, Corner's office, Probation, Keller Center, CORA, Law Enforcement. Some additional data sources could include Human Services Agency, Police Departments, 911 Dispatch, Child and Family Services, SMC Office of Education, Other Mental Health Agencies such as Star Vista.

Barbara Hammerman Award

In 2005, the Domestic Violence Council established the Hammerman Award, ratified by the Board of Supervisors of San Mateo County, for the purpose of recognizing outstanding law enforcement officers for their contribution and service to survivors of domestic violence and their children. In 2009 the award was expanded to include professionals who provide services to victims of domestic violence.

The Hammerman Award was created in honor of the late Barbara Hammerman, a City of San Mateo Police Lieutenant, whose legacy of exemplary service and dedication to survivors of domestic violence serves as a model for the County's law enforcement community. This award is presented annually to one person for exceptional service in addressing domestic violence.

GENERAL RULES

• Nominees for the Hammerman Award may be any sworn law enforcement officer or other domestic violence service professional working in San Mateo County without regard to race, color, nationality, sexual orientation, disability, or religious or political affiliation.

 Individuals and organizations may submit nominations to the Domestic Violence Council via email at tbeat@smcgov.org.

• The official nomination form (or photocopy) must be used. Additional unsolicited information will not be considered.

• The Selection Panel will be composed of prominent members of law enforcement, the judiciary, and the domestic violence advocacy community.

· Awards may be posthumous.

· Please note whether any information contained in this nomination form concerns an individual case that is currently active in the judicial system.

 \cdot The award recipient will be announced in October during Domestic Violence Prevention Month.

 \cdot The award will be accompanied by a \$500 honorarium.
