**Discussion** on status of Peninsula Open Space Trust parcels excluded from wildlife conservation easements that are associated with the Lake Lucerne Mutual Water Company.

#### **PUBLIC SPEAKERS:**

Joe Barroso Kerry Burke Dante Silvestri BJ Burns

#### **COMMITTEE ACTION:**

No action required. The Committee discussed that POST will be available to discuss this item and answer questions at the August 2023 AAC meeting, clarified the committee's questions for POST regarding this project, discussed if the parcels without wildlife easements can be made available for new agricultural activities, and shared a desire to have impacted property owners join the continuing discussion.

Joe Barroso, Local Cattle Rancher, asked about potential irrigation needs and shared about his experience maintaining the Cloverdale Ranch irrigation system for several decades.

Kerry Burke, Land Use Consultant, raised questions for Midpeninsula Regional Open Space District (MROSD) regarding how this project will be consistent with their current agricultural policies regarding fostering and improving agriculture, if these parcels have prime soils, and what their responsibility is moving forward after the sale.

Dante Silvestri, Local Cattle Rancher, asked about related water rights on parcels that are not being farmed, how critical this water is to local agricultural activities, writing in utility easements today for future use before the acquisition/transfer, and other lands with wildlife easements.

BJ Burns, Local Farmer and previous committee member, raised questions about if the Cloverdale Ranch house is already occupied by a ranger, how the Cloverdale Ranch water and irrigation system can be protected and kept available for agricultural use on the coast, ensuring public will not

Why were three (3) parcels excluded from the Wildlife Conservation Board Conservation Easement? Was it intentional and if so why?

The State of California invested \$10 million, partnering with POST in the protection of the Bolsa Point Ranch portion of Cloverdale. These funds came to POST through a grant from the State Wildlife Conservation Board (WCB). In return, POST granted a Conservation Easement of equivalent value (based on an appraisal completed at the time of the grant) covering parcels totaling 1010 acres. Since the grant funds were less than the value of an easement covering all of Bolsa Point Ranch, lands with existing development were excluded from the WCB Conservation Easement area including the 3 parcels in question.

What is the future intention of the three (3) excluded parcels? Why are they not part of farmland futures and/or can they be offered to farmers?

The 3 parcels are included within the portion of Cloverdale over which Midpen holds a purchase option. These parcels were not in active agricultural production at the time of POST's acquisition of Bolsa Point Ranch, and to the best of our understanding had not been in production for many years prior to that. Portions of the property that were in production at that time were leased and then sold to farmers - subject to a Conservation Easement - a few years after POST's acquisition.

#### **DISCUSSION**

Will the project be visible from a public road?

Yes, the project site is visible from San Mateo Road/Highway 92; however, the Event is secondary, and supplemental to ongoing agricultural use of the land, and as a seasonal event not uncharacteristic for the area.

Will any habitat or vegetation need to be removed for the project?

No.

Is there prime soil on the project site?

There are prime soils interspersed throughout the site as illustrated in Attachment B.

#### A. KEY ISSUES

1. Agritourism Event Certificate of Exemption

Planning staff has reviewed this application for conformance with the Agritourism Guidelines. The proposed Agritourism activities are secondary and supplemental to established agricultural uses on the property. All activities are temporary, support the economic viability of the farm and does not prevent future agricultural uses on the land. Staff has determined that this application is in compliance with the Agritourism Guidelines.

2. Compliance with the Williamson Act:

The subject property is not encumbered by a Williamson Act contract.

#### **FINDINGS**

- 1. That the Agritourism use is compatible with the long-term agricultural uses of the land because the proceeds from the pumpkin sales support the economic viability of the farm. This is an established agricultural farm; therefore, this finding can be made.
- 2. That the Agritourism operation will not adversely affect the health or safety of persons in the area and will not be materially detrimental to the public welfare or injurious to agricultural property. The applicant will hire five (5) employees for the season to assist with parking and pumpkin sales. This finding can be made.

- 3. That the Agritourism operation is in substantial conformance with the goals set forth in the San Mateo County Agritourism Guidelines. Specifically, that the operation is secondary and supplemental to existing agricultural operation on the land. Due to the ongoing agricultural uses on the property, this finding can be made.
- 4. That the proposed use and activities comply with all relevant provisions of the General Plan, Local Coastal Program and San Mateo Zoning Regulations.
