Re: 2023 Slip-Out Repair Near 2665 Higgins Canyon Road Project [County Project No. 08H26, County Project File No. 5088]

Dear Property Owner/Resident:

The County of San Mateo Department of Public Works awarded a contract to:

Half Moon Bay Grading & Paving, Inc. 1780 Higgins Canyon Road Half Moon Bay, CA 94019 (650) 726-3588

to perform work on the above-referenced road near 2665 Higgins Canyon Road. Construction is scheduled to begin as early as September 19, 2023, with the work taking approximately two (2) months to complete. The Project consists of stabilizing the failed slope by installing a soil nail wall, installing subsurface drainage features, reconstructing the roadway, and installing a guardrail.

Road Closure During Construction

A section of the road near <u>2665 Higgins Canyon Road</u> will be inaccessible at the Project site during the entirety of construction. To expedite the construction, the road will be closed 24 hours per day, and 7 days per week to allow contractors to work longer hours and weekends, which means the road will remain closed during non-construction hours. Residents impacted by the road closure must use alternative routes. Emergency services have been notified of the closure and will be updated as the work progresses.

Advance warning signs will be posted at both ends of Higgins Canyon Road to warn drivers about the road closure.

Other Slip-Out Repair Projects on Higgins Canyon Road

Minerva Construction, Inc. will begin construction at a different location for the slip-out repair near 2180 Higgins Canyon Road in late September 2023. Both construction projects

will be overlapping for a period of time. Higgins Canyon Road from 2175 to 2665 will remain open for local traffic only. Residents in between 2175 and 2665 Higgins Canyon Road will be allowed to cross the project area at 2180 Higgins Canyon Road during this time. Delays are expected; however, access will always be provided for residents between 2175 and 2665 Higgins Canyon Road. For your safety and the safety of others, please be patient, drive carefully, and follow the directions of the construction crew while traversing the work areas.

The safety of impacted residents and our construction crews remain our top priority and we will continue to work collaboratively with the two contractors on both sites to bring these repair projects to completion before the next rainy season. Every effort has been and will continue to be made to minimize any inconvenience to you due to this construction. However, there will be disturbances and thank you for your patience and cooperation.


