2	Can a Creditor Reference be used in lieu of a 2 Financing References as stated in Tab 6 Item 3 for firms that are financially solvent?	Yes
3	Insurance Section (Page 11 of RFP) – The insurance section requires that the County and its officers, agents, employees, and servants be added as additional insureds on any such policies (except workers compensation). Professional liability policies are unlike commercial general or automobile liability policies, in that they are "non-endorsable" (written for the named insured only). Can the County include the professional liability policy with the workers compensation exception for said endorsement?	This is the County's standard insurance requirement. The PDU is open to receiving documentation from the selected firm(s) that can substantiate why this requirement cannot be met as provided in the RFP.
