**Re: Proposed Improvements on 16th Avenue from End to approximately
789 16th Avenue – North Fair Oaks Area
[County Project No. RW409; Project File No. 5091]**

Dear Property Owner:

The County of San Mateo Board of Supervisors (Board), at their meeting on June 18, 2002, adopted minimum road standards and a priority list for improving roads in the North Fair Oaks area so that minimum road improvements, where desired by the property owners, can be constructed and paid for by the County. We are continuing to construct roads to the adopted standards and priority list as funding is available. 16th Avenue is next on the priority list, and we are asking for your input regarding this road project.

We are surveying property owners on 16th Avenue between 789 16th Avenue and the end of 16th Avenue regarding road improvements. The segment of road between 789 16th Avenue and the intersection with 15th Avenue has existing improvements such as curb, gutter, and sidewalk and is not part of this survey process.

We are surveying your block of 16th Avenue to determine whether or not minimum improvements are now desired and, if so, which of the following adopted standards for your area, as described below, is preferred:

- Option 1** – Maintain as is.
- Option 2** – Repair and resurface the existing pavement.
- Option 3** – Reconstruct road with 18 feet of pavement with 6-inch-wide concrete bands.
- Option 4** – Reconstruct road with 18 feet of pavement with 2-foot-wide valley gutters.
- Option 5** – Reconstruct road with 18 feet of pavement with 3-foot-wide valley gutters.

Based on the results of this survey, reconstruction of the road may be implemented (Options 3 through 5). In those cases (Options 3 through 5), the improvements will be centered in the road right-of-way unless they must be shifted to avoid trees or other major encroachments in the road right-of-way. A potential shift of the road and/or edge improvements may be required or may result in a

narrower road width at some locations. Removal of property owner’s encroachments (such as mailboxes and landscaping) within the road improvement section in the County road right-of-way appear to be necessary based on our observations of the existing conditions.

Storm drainage along 16th Avenue generally flows along the road shoulders from the end of 16th Avenue towards 15th Avenue. This includes ponding at localized low points along the road shoulders and existing vegetated or pervious surfaces, which allow for stormwater to infiltrate into the ground. Many roads in the North Fair Oaks area do not have formal storm drainage facilities, which includes 16^h Avenue.

The Road Standard Options for your area include the construction of valley gutters (Options 4 and 5), which would result in conveying surface runoff more efficiently. These Options would generally no longer provide areas for stormwater to percolate into the existing permeable shoulder areas. On the other hand, reconstructing the road with concrete bands along the edge of pavement (Option 3) would allow roadway surface runoff to drain off the road into the roadway shoulder areas for water to infiltrate into the permeable shoulder material. With Options 3 through 5, the Department would evaluate options and opportunities to construct subsurface storage and infiltration facilities for incorporation into the project where existing utility conflicts do not exist, in an effort to improve the existing drainage conditions.

Enclosed are pictorial representations of Options 3 through 5 for your reference. Our survey crew has spray painted the proposed locations for the 3-foot-wide valley gutter with a 18-foot-wide road consistent with Option 5. The pictorial representations and information listed below provide you with a description of how you can determine the improvement locations for Options 3 through 5 based on the spray paint marks.

Additionally, we have provided a list of streets where Options 3, 4 and 5 were previously constructed.

Option	How to Locate Option on 16th Avenue	Location of Constructed Option
3 (18' wide road with 6" concrete band)	The outer edge of the 6-inch concrete band can be referenced by measuring from the inner spray paint mark outward away from center of the road six inches (6").	Placitas Avenue from Oak Drive to End
4 (18' wide road with 2' valley gutters)	The outer edges of the 2-foot valley gutters can be referenced by measuring from the inner spray paint marks away from center of the road by two feet (2').	Fair Oaks Avenue from 14 th Avenue to 15 th Avenue San Benito Avenue from Fair Oaks Avenue to End

- (1) Improvements will not be constructed unless at least fifty percent (50%) of the property owners on a given block (based on front footage) indicate that improvements are desired; and**
- (2) Should at least fifty percent (50%) of property owners on a given block vote for improvements, as stipulated above, the option constructed will be based on:**
 - a. The option that receives at least fifty percent (50%) of the vote (based on front footage) will be constructed.**
 - b. Should no option receive at least fifty percent (50%) of the vote (based on front footage), the default option, as previously approved by the Board, will be Option 3.**

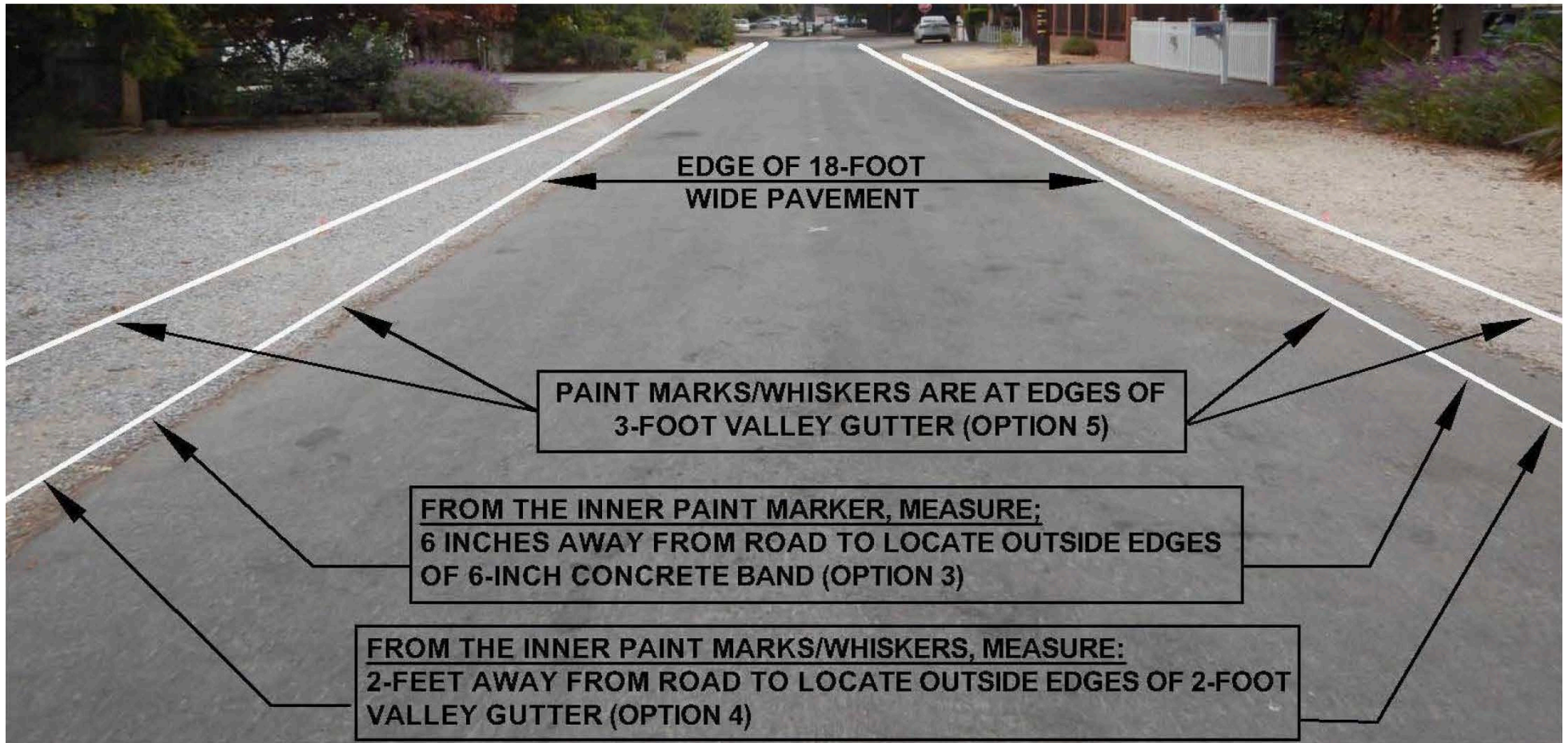
SIXTEENTH 16TH AVENUE FROM END TO APPROXIMATELY 789 16TH AVENUE

Please take the time to fill out the form and mail it to us by **Friday, January 26, 2024**. **Street improvements will not be constructed unless at least fifty percent (50%) of the property owners on a given block (based on front footage) indicate that improvements are desired.**

The following should be the minimum standard used for reconstructing the street adjacent to my property. (Please check **only one**):

- Option 1** – Maintain as is.
- Option 2** – Repair and resurface the existing pavement.
- Option 3** – Reconstruct road with 18 feet of pavement with 6-inch wide concrete bands.
- Option 4** – Reconstruct road with 18 feet of pavement with 2-foot valley gutters.
- Option 5** – Reconstruct road with 18 feet of pavement with 3-foot valley gutters.

Note:

Should a majority of property owners on a given block vote for improvements, the option constructed will be the one that receives at least fifty percent (50%) of the vote (based on front footage).

If no option receives at least fifty percent (50%) of the vote, then Option 3, the default option, will be constructed.
