# INTRODUCTION SUMMARY

Gross earnings for the month ending December 2023 was 3.672%. Gross earnings for the quarter ending December 2023 was 3.530%. Current average maturity of the portfolio is 1.60 years with an average duration of 1.46 years. The current Par Value of the pool is \$8.556 Billion. The largest non-government aggregate position is currently Natixis NY Branch at 1.81%. The portfolio continues to hold no derivative products.

The estimated earnings for FY 2023-24 is 3.75%.

The San Mateo County Pool complies with Government Code Section 53646, which requires the ability to meet its expenditure requirements for the next six months.

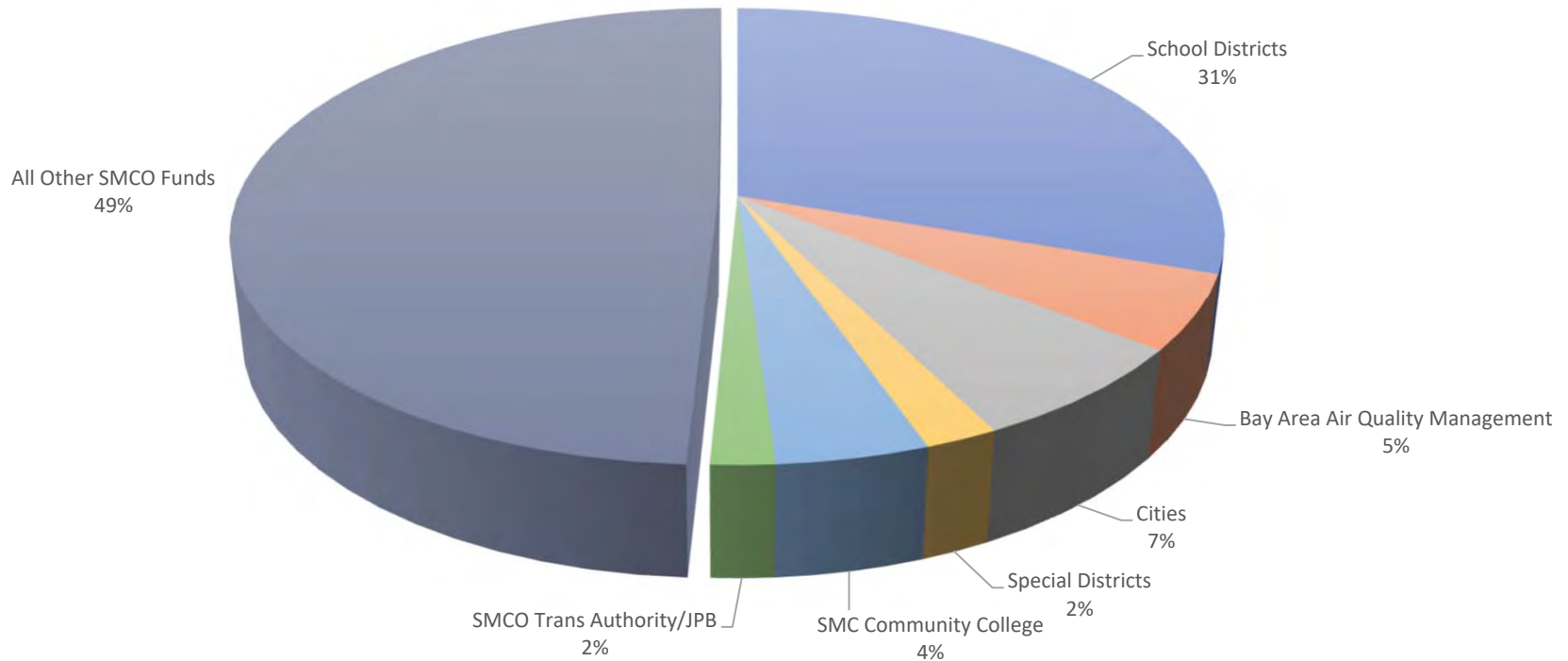

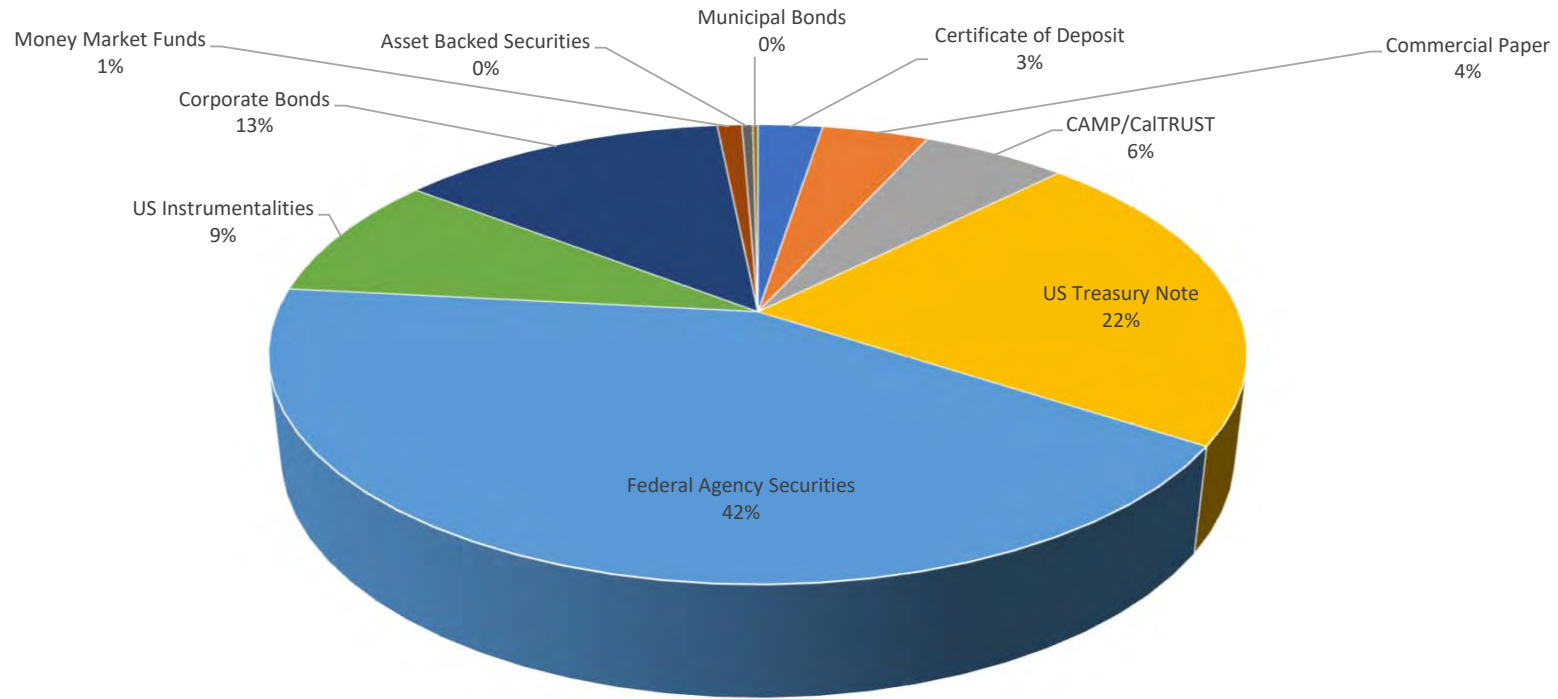
