Hello Rob,

I hope all is well. We have become aware of two more sewer spills in the East Palo Alto Sanitary District service area in the last two months. So far we know of at least three spills.

Would you or one of the LAFCo commissioners ask why these three sewer spills have not been reported to the State Water Board?

Here is a screenshot of the State Water Board's website, as of today February 5th. The last spill reported was in 2009. We feel that it is important to be completely transparent and honest about reporting spills; and that the public being served by the EPASD is aware of how the agency is being operated. It appears that public health is not being addressed properly.

Our Board feels these questions need to be asked during this week's public hearing. Attached are photos of the spills.







