- STAFF RESPONDING TO HCD REVIEW RESPONSE TO DRAFT HOUSING ELEMENT:
 - HIRED CONSULTANT (EPS) TO REWORK HOUSING SITES & HOUSING CAPACITY
 - DOH CONSULTANT (ROOT POLICY) WORKING ON UPDATING AFFH COMPONENT
 - EXPECTING TO BRING TO PC/BOARD IN MAY/JUNE FOR CERTIFICATION
- BOTH **SAFETY ELEMENT** & **ENVIRONMENTAL JUSTICE (EJ) ELEMENT** ARE IN DATA GATHERING & EXISTING CONDITIONS ANALYSIS PHASE.
 - Safety Element: website launching soon & outreach events expected to begin in March.
 - EJ Element: working on identifying initial list of impacted communities based on available data



THE NORTH FAIR OAKS COMMUNITY PLAN 10-YR REVIEW IS IN ITS FINAL STAGES.

- DRAFT REPORT WITH ANALYSIS AND RECOMMENDATIONS ANTICIPATED IN JUNE \cap
- PERFORMANCE METRICS AND DASHBOARD IN JULY/AUGUST
- NFO PHASE 4 REZONE COMPLETED OCTOBER 2023
- RE-ENGAGE PRINCETON COMMUNITY TO COMPLETE **PLAN PRINCETON** BY THE END OF THE YEAR
 - PUBLIC & STAKEHOLDER ENGAGEMENT MEETINGS TO BE HELD LATE SPRING/EARLY SUMMER
 - INTEGRATE NEW STATE SEA-LEVEL RISE GUIDANCE INTO THE PLAN



- MOSS BEACH SR-1 CONGESTION & SAFETY IMPROVEMENTS PROJECT
 - PROJECT INITIATION (PID) PHASE COMPLETE.
 - INITATING PROJECT APPROVAL & ENVIRONMENTAL (PAED) PHASE WITH SMCTA IN SUMMER.
- MIDCOAST TRANSPORTATION DEMAND MANAGEMENT PLAN
 - JOINT PLAN WITH THE CITY OF HALF MOON BAY. INITIAL COMMUNITY ENGAGEMENT & EXISTING CONDITIONS ASSESSMENT COMPLETE.
 - EXPECTED COMPLETION BY Q1 2025.
- MIDCOAST PARALLEL TRAIL GAP CLOSURE STUDY (CARLOS STREET)
