
Project Overview





Technical Analysis

The Technical team will use



Traffic data to see the number of people, bikes, and cars at a given street or intersection during peak periods.



Speed and density of traffic, and how often or far people are traveling to determine the current quality of transport infrastructure.



Crash data collected between 2018 to 2022




Travel data, travel patterns, and information about how travelers experience the sidewalk, road, and transit to create a mobility profile.




Crash Analysis
