Pride Center shifts to "mask friendly" policy - Face masks no longer required!

Did you know it's been over one year since Pride Center re-opened for on-site visits? Up until now, we required face masks while on-site. Now that time has passed, as a team we've intentionally decided to revise our on-site mask policy.

2024 San Mateo County Legislative Session Program

Please review the <u>County's Legislative Program</u> for LGBTQIA+ topics. We will discuss and learn how to move forward with requests for the 2025 Legislative Program.

LGBTQIA+ Commission Experience with the County's Legislative Program

In spring of 2022, Commissioner Craig Wiesner brought Senate Bill 107 regarding Gender-affirming health care (Representative Scott Wiener) to our attention. He requested to be on the Commission Agenda, created a proposal with content for the Commission to study and then discuss.

We voted to provide our recommendation to the County's Chief Legislative Officer (following the process document called "Legislative Engagement Policy.").

The Chief Legislative Officer created an analysis that was provided to the Board of Supervisors for a learning and discussion. July 12, 2022: The BOS voted and approved Resolution _____ to support SB107 and to issue a letter in support of the measure.

Context

Met with Senator Scott Wiener's Legislative Aide Alan Moore about SB 107. Senator Wiener believes that support from the San Mateo County Board of Supervisors would be very helpful in getting this legislation passed and on the governor's desk. Here is a link to the text of the legislation that was released last evening (note that this is a rewrite of a previous SB107 that had to do with CalFresh so please excuse all the deleted text):

Based on my discussion and research on this legislation, I would like to recommend to the commission that we encourage the Board of Supervisors to pass a resolution supporting SB 107., a bill to protect transgender children and their families traveling from other states. The bill would also protect California citizens, medical providers, and others from criminal and civil penalties for providing services, that are legal in California, to and supporting those children and families within the state of California.

Today's Agenda allows for full discussion on all aspects of SB107 and the pros and cons this bill by the LGBTQ Commission.

Background: (This background is written by Craig, more comprehensive background information will be forthcoming from the state Senate). Legislation is being considered and passed in states across the country that would criminalize, or provide civil litigation powers to citizens, to take action against anyone providing or supporting the provision of gender-affirming care to children. Some forms of that legislation include allowing criminal or civil actions to be taken against individuals in other states, like California, where gender-affirming care is legal. For example, if a family residing in Texas leaves the state to come to California for their child's gender-affirming care, Texas law might allow any Texas citizen to sue any Californian for aiding in the provision of that care. Another state's law might cause a California citizen to be indicted with criminal charges for supporting a family from that other state getting gender-affirming care in California.

SB 107 would provide protection to families and children traveling to California, AND to California citizens against criminal charges and civil lawsuits. Specifically:

The United States Constitution generally requires a state to give full faith and credit to the public acts, records, and judicial proceedings of every other state. Existing law sets forth procedures by which a person may enforce a judgment for the payment of money issued by the court of a state other than California. Existing law authorizes a California court or attorney to issue a subpoena if a foreign subpoena has been sought in this state. Existing law generally prohibits a provider of health care, a health care service plan, or a contractor from disclosing medical information regarding a patient,

enrollee, or subscriber without first obtaining an authorization, unless a specified exception applies, including that the disclosure is in response to a subpoena.

This bill would declare another state's law authorizing a civil or criminal action against a person or entity that allows a child to receive gender-affirming health care to be contrary to the public policy of this state. The bill would prohibit the application of that law to a controversy in state court, and would prohibit the enforcement or satisfaction of a civil judgment received under that law. The bill would prohibit a provider of health care, a health care service plan, or a contractor from releasing medical information related to a person or entity allowing a child to receive gender-affirming care in response to a criminal or civil action, including a foreign subpoena, based on another state's law that authorizes a person to bring a civil or criminal action against a person or entity that allows a child to receive gender-affirming health care. The bill additionally would prohibit law enforcement agencies from making, or intentionally participating in, the arrest of an individual pursuant to an out-of-state arrest warrant based on another state's law against receiving or allowing a child to receive gender-affirming health care. The bill would declare its provisions to be severable.

The Senate Judiciary Committee has reviewed this legislation and has had a constitutional scholar review it and all feel that they are on sound legal ground vis-a-vis the Full Faith and Credit clause of the US Constitution.



How to Take a Position on Pending Legislation



San Mateo County Boards and Commissions Legislative Engagement Policy

In order to facilitate consistent and coordinated legislative advocacy on behalf of the County of San Mateo, all County Board and Commission members are expected to follow the Legislative Coordination and Advocacy Policy.



Key Points to Remember

Do not take any action that would imply the County's support or opposition to any pending legislation, budget proposal, or other policy unless it is consistent with Board-approved positions.

All legislative engagement must be coordinated through the Intergovernmental and Public Affairs Unit (IGPA) in the County Executive's Office. Your staff liaison can facilitate conversation with this Unit.

If you appear before a legislative body to express a personal opinion, you must state for the record that you are speaking as a private citizen, and not on behalf of the County or your Board or Commission.

Subject: Adopt a resolution in support of SB 107 (Wiener) Gender-affirming health care.

RECOMMENDATION:

Adopt a resolution in support of Senate Bill 107 (Wiener), a bill regarding gender-affirming health care.

BACKGROUND:

In response to a recent proliferation of laws and executive actions around the country that restrict the ability of transgender youth to obtain gender-affirming medical treatment, California State Senator Scott Wiener introduced Senate Bill (SB) 107. This bill establishes California as a refuge for transgender and gender-diverse youth and their families to secure care without facing criminal or civil penalties.

Specifically, the bill would prohibit health care providers and service plans, law enforcement agencies, and legal entities across the state from providing sensitive medical information, participating in arrests, and issuing subpoenas in proceedings that relate to another state's law that interferes with a person's right to allow a child to receive gender-affirming health care.

DISCUSSION:

SB 107, the gender-affirming health care bill, would offer opportunities for individuals who identify as Transgender or gender-diverse to seek health care in California without fear of legal repercussions even from states that have criminalized such care.

The County of San Mateo has a long history of supporting the LGBTQ+ community and the Transgender community. The County of San Mateo has sustained an active LGBTQ+ Commission, which is the first of its kind in the state, and supports the development of the County's Pride Center, now in its fifth year. In addition, this Board and the County have established a Transgender Policy and Sexual Orientation, Gender Identity and Expression (SOGIE) training for employees. This is

honored via proclamation of an annual Transgender Day of Remembrance that includes raising the Transgender Flag and offering transgender-oriented health care for County clients.

The LGBTQ+ Commission has requested the Board of Supervisors to adopt a resolution in support of this legislation.

A complete analysis of the proposed legislation can be found in the attached form.

RESOLUTION IN SUPPORT OF SENATE BILL 107 (WIENER), A BILL REGARDING GENDER-AFFIRMING HEALTH CARE

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California has long fostered a welcoming environment for members of the LGBTQ+ community; and

WHEREAS, multiple states and other jurisdictions around the country have proposed or passed legislation or executive actions that restrict the ability of transgender and gender-diverse youth to obtain gender-affirming medical treatment; and

WHEREAS, according to the American Academy of Pediatrics, failing to provide evidence-based information to assist transgender and gender-diverse youth and families in medical decision-making can prolong or exacerbate gender dysphoria and contribute to abuse and stigmatization, and recommends that "youth who identify as transgender have access to comprehensive, gender-affirming, and developmentally appropriate health care provided in a safe and inclusive clinical space;" and

WHEREAS, the Trevor Project's 2021 National Survey on LGBTQ Youth Mental Health found that 52% of LGBTQ youth seriously considered attempting suicide in the past year, and that youth who identify as transgender or gender-diverse experience disproportionately high rates of homelessness, physical violence, substance abuse, and high-risk sexual behaviors; and

WHEREAS, California State Senator Scott Wiener introduced Senate Bill 107 to provide protections for transgender and gender-diverse youth and their families to be able to seek appropriate health care in the state of California; and

WHEREAS, the County of San Mateo strives to promote the principles of equality and justice for all people, recognizing that the diversity of our communities is one of our greatest strengths; and

WHEREAS, the County of San Mateo in June 2014 established California's first dedicated LGBTQ Commission to pursue the development of policies and programs to support the LGBTQ+ community and ensure access to services that are welcoming, respectful, and responsive; and

WHEREAS, the County of San Mateo launched the San Mateo County Pride Center, now in its fifth year, which offers a myriad of support services for the Transgender and Gender-Diverse community; and

WHEREAS, the proposed legislation aligns with the County of San Mateo's long history of supporting the Transgender community, including an annual observation of the Transgender Day of Remembrance and the raising of the Transgender Flag, and the development of a Transgender Policy for County employees.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

Board of Supervisors of San Mateo County supports Senate Bill 107 regarding genderaffirming health care and directs the President of the Board to issue a letter in support of the measure.
