Consideration of a Coastal Development Permit (CDP), Planned Agricultural District Permit, After-the-Fact Grading Permit, Architectural Review Permit, and adoption of a Mitigated Negative Declaration, to construct a new 2,750 sq. ft. single-story, pre-manufactured affordable housing unit with a 360 sq. ft. detached two-car carport, and supporting improvements, on a legal 17.4-acre parcel. A total of 1,250 cubic yards (c.y.) of grading is associated with the project, including 630 c.y. of cut and 620 c.y. of fill, and no tree removal. The project is located within the Cabrillo Highway State Scenic Corridor in the unincorporated Pescadero area of San Mateo County. The CDP is appealable to the California Coastal Commission.
