Continuum of Care (CoC)Builds Funding: Key Facts



\$175,000,000 Available Funding (approximately 25 awards expected).



Funds are to create new Permanent Supportive Housing units, which can be part of larger projects



New PSH units are for individuals and families experiencing homelessness, where one member of the household has a disability.



Only one CoCBuilds application can be submitted by San Mateo County for up to \$7.5M



PSH units will be filled by referrals through Coordinated Entry.



Eligible Uses of Funds and Match Requirements

- The majority of funds must be used for capital development of new PSH units (Acquisition, Rehabilitation, New Construction)
- **Up to 20**% of the requested funds can be for support costs (Operating costs, Supportive Services, Project-Based Rental Assistance).
- Up to 10% of the requested funds can be for administrative costs
- 15-Year Use Requirement

Required Match

A minimum 25% match must be met (cash or in-kind)



Some Tips for Applicants

- If the applicant entity does not have a SAM.GOV number, apply for one now.
- What if you think you have a competitive project, but cannot provide all the required attachments by the local application deadline of September 27?
 - Include an attachment using the name and number of the required attachment that explains:
 - Why the missing attachment is not relevant to your project OR
 - · Why you are unable to provide the missing attachment by the deadline
