Comments	\circ I support whatever was said in the last meeting where we had
	10 people/public comment about the stop sign issues.
	 DPW did say that they were going to wait until things settle,
	however, it's better to do something than nothing.
	\circ I do see people using the crosswalks – some drivers yield, and
	some don't.
	Council member Niket Sirsi
	 I think the sudden opening of Middlefield created like a whole
	new flow and there's a lot of uncertainty with stop signs. I think
	the pedestrians need to use the crosswalks and take some
	responsibility with doing their part before we ask about wanting
	other things.
	\circ I also don't want to rush things and take our time with things,
	but I also don't want us to create more issues.
	\circ I do feel safer with the new layout – but I do think we just have a
	lot of bad drivers in the area. Stop signs can also be more
	dangerous, as a bicyclist – drivers pay attention to more
	pedestrians than bikers.
	\circ Maybe we can tap in the Sheriff's Office to see some data that
	they might have to contribute.

	 I live near the area, and it is not safe at all. Something must
	change.

	\circ We heard from a few residents that actually cross that area and I
	want to challenge how many council members have actually
	walked in that area and have experienced what these residents
