- When the Clerk calls for the item on which you wish to speak, click on "raise hand" feature. Speakers will be notified shortly before they are called to speak. Each speaker will have one minute to speak for each agenda item.

# \*Written Public Comment:

Written public comments may be emailed in advance of the meeting, and such written comments should indicate the specific agenda item on which you are commenting. Please read the following instructions carefully:

- Your written comment should be emailed to <u>communityaffairs@smcgov.org</u> by 5:00 p.m. on the day before the meeting.
