Somehow after the presentation was complete and the commissioners were asking questions, both Sheriff Corpus and Undersheriff Perea joined in the discussion. The Sheriff joined in on Zoom to talk about the child care center that she wants to implement and the Undersheriff without invitation took a seat at the table the speak about why the incarcerated persons cannot have physical mail in the jails. Neither their presence nor their participation was on the agenda. As a community member, I believe this participation by the Sheriff and Undersheriff was completely inappropriate. Whatever their motives were, it was clear to me that they had their own agenda to control the direction of the meeting and the presentation. Additionally, there was an obvious attempt to discuss the childcare center project that has been apparently put on pause by the county manager.

It is exactly this type of behavior by the Sheriff and Undersheriff that calls for a truly INDEPENDENT civilian board with an Inspector General. They used this meeting to attempt to further their own agenda. They are treating this advisory commission as an extended function of the Sheriff's office. This behavior should not be allowed and needs to be halted immediately.

I have participated in person at every single ICAC meeting since they began and will continue to do so. I seriously hope the Sheriff and her office are admonished for their behavior and have it made clear to them that it will not be tolerated.

Public Comment November 20, 2024 San Mateo County Independent Civilian Advisory Commission on the Sheriff's Office

The San Mateo County Sheriff's Office has a systemic culture of hatred of women and children. The witchhunt against Sheriff Cristina Corpus following the \$8million settlement of Detective Carryn Barker, displays the obvious bias against women, discrimination against female sheriff staff and civilians, and reprehensibly, unequal access to justice.

Let me remind you that the prior male sheriffs, Carlos Bolanos and Greg Munks, were caught by FBI Operation Dollhouse during a raid of a brothel of sex trafficked women and minors. Neither of these male Sheriffs lost their jobs over obviously criminal behavior. I don't care who Corpus is intimate with as long as it's a consenting adult.

Barker's lawsuit referenced a previous female whistleblower who revealed pornography being shared on Sheriff servers and reported by the late Michael Stogner of San Mateo County News.

I am a female victim of this systemic hatred of women and children by law enforcement where the SMCSO is responsible for my suffocation and my daughter's strangulation and our violent kidnappings under color of law because of SMCSO deputies Gerono Urena, Sgt. William Young, Detective Joe Fava, District Attorney Inspector James Haggarty and many others who refused to prosecute my abuser, a rich white man, for domestic violence. Young removed Barker off my case, Fava told me they would not investigate, Urena and Haggarty falsified evidence against me, committed perjury, filed false police reports and concealed exculpatory evidence. They DARVO'd me.

My Federal Lawsuit and the complaints of dozens of other woman at the San Mateo County Domestic Violence Council meetings, provide ample evidence that the systemic hatred, discrimination and unequal access to justice for all females, is rampant at the Sheriff's Office which Cristina Corpus claims to be cleaning up. There can be no transparency if reports, such as the one written against Cristina Corpus remain biased and dishonest. If Corpus is cleaning up the good ole' boys club, there is motive to harm her. Supervisor Noelia Corzo displays contempt for women of domestic violence, as evidenced by her behavior at the DVC meetings. Noelia Corzo is untrustworthy and is the one who should be resigning.

Here are the videos of my daughter's violent strangulation and kidnapping under color of law, and the link to my Federal Lawsuit, which was dismissed, but contains ample opportunity to investigate the behavior of all male Sheriff Staff who's actions led to my daughter's horrific, videotaped strangulation by men in law enforcement displaying a disgusting culture of hatred towards women and children and a gross imbalance of power.

Public Comment for Agenda Item 4: Judge's Independent Report
