#### Concerns: The inspection team had several concerns: - Youth are no longer going to court for regular reviews. Now they only go to court if things are not going well. Staff thinks these reviews are important for motivation and help keep the youth on track. The commission inspectors agree with this and recommend that these regular reviews be reinstated. - The county has asked Glenwood to stop using creek water to water the garden due to severe water shortages. This is unfortunate as they use the fruit and vegetables from the garden for food. Right now, they are carrying grey water into the greenhouse to water those plants. - We would like the county to come out to paint the walls on the unit. Right now there is peeling paint on the walls. - The numbers at Glenwood have been down for a while now. This reflects what has been going on statewide. Hall. Their latest AWOL was on 8/16/2014 and he is still not in custody

How is staff backup handled during grave-yard shift?: There are 1-2 staff that provide backup for breaks etc. If they need backup in an emergency, they call the sheriff. If someone doesn't show up for a shift,
staff has to stay until backup is available, though this is very rare.

Describe general staff and minor interactions: Very good. Respectful. It is clear that the staff really ca
about the youth and the youth know this.
Describe the diversity of staff: <u>Diverse – Latin, African-American, Polynesian, Middle Eastern</u>
Comments: They try to have at least four staff during awake times so they can cover all programs and
have emergency response staff available.

lunch were very happy at the facility. They liked the opportunities available to them. When asked about
school, one youth said that they really taught him there and compared it to his old school where he was
just given a book and told to read it and highlight it .
The minors were kept busy during the day with a variety of different activities, including school,
recreation, athletics and shops. They seemed to interact quite well with the staff and expressed
appreciation for the efforts of the staff. They said they were well-fed and seemed generally positive about
their experience at Glenwood.

They look for new experiences for the youth and try to show them alternatives to gang life. Staff are always looking for projects for the youth to work on – especially to work with their hands. The youth at Glenwood built all the garden boxes for the garden and are currently working on an outdoor pizza oven. Staff are hoping to bring more tradespeople up to talk with the youth. And they spoke of bringing an old car in that the youth could work on. **Discipline of Minors** Describe the discipline process of minors: They use a point system to earn privileges. The discipline process involves taking points away or removing privileges (softball, home pass). Describe the general atmosphere of the classrooms: Students were in gym class when we toured the
school. But the interactions we observed during the volleyball game were positive. During lunch
conversations, students were positive about school and their relationship with the teachers.

from 2006/7. They are not standards aligned but they were pretty new and looked good. They are in the
process of buying new common core aligned math textbooks with others to follow.
Access to Computers/Internet?:   Yes   No Details: Currently youth do not have access to computers except in special circumstances (community college application, financial aid). Glenwood doesn't have the
staff to monitor computer use right now. They will start using ipads in the classroom soon.

Describe the relationship between school and juvenile hall staff: This relationship seems to be quite good.
Camp Staff interviewed seem committed to providing the best possible educational experience for all
wards.
Describe access to school, recreation, etc. for minors confined to their rooms: Educational and
recreational programs are available to all minors at all times. Should a serious breach of expected
behavioral standards occur, the minor would be sent to the YSC. While at the Camp, all minors attend
class. Recreational opportunities include scheduled physical education classes, basketball, volleyball,
softball and weight training. Camp minors also have the opportunity to compete against minors from
other camps in organized team activities such as basketball and cross country.
Comments:

Recent years have seen many positive trends in the Camp's educational program. Highlights of these improvements include:

- 1. The installation of a new principal who has considerable experience with educational programs for incarcerated youth.
  - 2. A well trained and CLAD certified staff, with experience in the use of SDAIE strategies with the Camp's English Learner students. As noted in the County Office of Education's Local Control Accountability Plan (LCAP) the needs of the Camp's English Learners remain a top educational priority. The school is currently using High Point as the academic program for English Learners. However, staff is now researching the possibility of adopting the state approved EDGE program for such students.
  - 3. The focus of the academic program on the improvement of academic language across the curriculum and the movement towards project based learning.
  - 4. The school now uses 2007 editions of Prentice Hall textbooks for science, math, biology, English and earth science. Teachers have been trained in issues relating to the Common Core and the County is now looking into the purchase of materials aligned to these standards.

- 5. In an effort to better prepare students for the State's assessment program, the school field-tested the new Smarter Balanced Assessment in the spring of 2014. Camp students will take these this assessment, along with the California High School Exit Examination, this coming spring.
- 6. Resource assistance is available two days per week and is being provided in individual, pair or group setting.
- 7. The program is now working towards gaining WASC Accreditation.

issue – they are the only ones that can paint the walls at Glenwood.
