Subject: Executive Summary – Water Rates and Charges for County Service Area

No. 7, La Honda Area

RECOMMENDATION:

Acting as the Governing Board of County Service Area No. 7 and after conducting the public hearing adopt:

- A) An Ordinance amending Sections 4.104.010 and 4.104.020 of Chapter 4.104 of Title 4, of the San Mateo County Ordinance Code, setting the water rates for FYs 2012-13 through 2014-15 for County Service Area No. 7, previously introduced on January 29, 2013 and waiver of reading the Ordinance in its entirety; and
- B) A Resolution authorizing the imposition of water service rates and meter service charges.

BACKGROUND:

On June 24, 1997, your Board adopted Ordinance No. 03781 adopting the water regulations and rates for CSA 7 and establishing a CSA 7 Customer Advisory Committee (Committee) to be an advisory group to the Director of Public Works. On June 1, 1999, your Board adopted Ordinance No. 03909 adopting the current water rates and charges for CSA 7.

On January 29, 2013, your Board adopted Resolution No. 072349, which set 9:00 a.m. on March 26, 2013, in your Chambers as the time and place for a public hearing to consider the water rates for FYs 2012-13 through 2014-15 for CSA 7.

The process to be followed in adopting the water service rates includes:

1. Hold a public hearing and receive testimony on the water rate and meter service charge increases for CSA 7.

- 2. After considering all written and oral objections to the water rates and meter service charges for CSA 7, close the public hearing and determine if there is a majority protest to the proposed water rates and meter service charges.
- 3. If there is a majority protest, terminate your consideration of imposing the water rate and meter service charge increases.
- 4. If there is not a successful majority protest, adopt the ordinance amending Sections 4.104.010 and 4.104.020 of Chapter 4.104 of Title 4, of the San Mateo County Ordinance Code, setting the water rates for FYs 2012-13 through 2014-15 for County Service Area No. 7.
- 5. Adopt the Resolution authorizing the imposition of water service rates and meter service charges for FYs 2012-13 through 2014-15 beginning with the June billings for each fiscal year (June 2013, 2014, and 2015).

DISCUSSION:

The January 29, 2013 Board Report explained the need for water rates and meter service charges to be increased. After the Board meeting on January 29, 2013, the Department sent a letter, which complied with Article XIIIC and XIIID of the State Constitution (Proposition 218), to property owners and customers with the proposed rates and information about the time and place of the public hearing, and explained a mechanism for rejecting the proposed rates via a "majority protest".

At the time this report was prepared, the Department had not received any written protests to the proposed water rates and meter service charges. We will report to your Board on any written protests that are received up to and including the date of the public hearing.

The Department is recommending that the proposed rates be approved and be evaluated annually to determine their adequacy. Staff will continue to work with the Committee to evaluate the financial condition of CSA 7 and develop long-term rates that will be acceptable to the ratepayers while adequately meeting the financial obligations of CSA 7.

County Counsel has reviewed and approved an Ordinance and Resolution as to form, and we will provide an alternate form of resolution if there is a majority protest in CSA 7.

Your Board's adoption of the water rates and meter service charges contributes to the Shared Vision 2025 outcome of a Healthy Community by providing revenue to CSA 7 and allowing for uninterrupted potable water service to CSA 7 customers.

FISCAL IMPACT:

There is no direct impact to the General Fund. Other associated CSA 7 charges are described in the Ordinance.

RECOMMENDATION:

Acting as the Governing Board of County Service Area No. 7 and after conducting the public hearing adopt:

- A) An Ordinance amending Sections 4.104.010 and 4.104.020 of Chapter 4.104 of Title 4, of the San Mateo County Ordinance Code, setting the water rates for FYs 2012-13 through 2014-15 for County Service Area No. 7, previously introduced on January 29, 2013 and waiver of reading the Ordinance in its entirety; and
- B) A Resolution authorizing the imposition of water service rates and meter service charges.

BACKGROUND:

On June 24, 1997, your Board adopted Ordinance No. 03781 adopting the water regulations and rates for CSA 7. The Ordinance established a CSA 7 Customer Advisory Committee (Committee) to be an advisory group to the Director of Public Works and review future rate and operational changes proposed for CSA 7.

On June 1, 1999, your Board adopted Ordinance No. 03909 adopting the current water rates and charges for CSA 7. The cost to operate and maintain the water treatment plant is shared between CSA 7 and the County's Probation Department for providing potable water to the Camp Glenwood Boys Ranch facility. Revenue generated from the residential customers with the current rates is not sufficient to adequately operate, maintain, and administer the CSA 7 water system and pay their share of the treatment costs.

On October 23, 2012, your Board adopted Resolution No. 072210 executing a three year agreement with Bracewell Engineering Inc. (Bracewell) for operation and maintenance services for County maintained small water and wastewater systems as it is not feasible for the Department staff to be certified operators. Bracewell had been providing certified operators to CSA 7 and CSA 11 since October of 2011, shortly after the Department's certified operator left County employment.

On January 29, 2013, your Board adopted Resolution No. 072349, which set 9:00 a.m. on March 26, 2013, in your Chambers as the time and place for a public hearing to consider the water rates for FYs 2012-13 through 2014-15 for CSA 7, and directed the Director of Public Works to send the necessary notices for said hearing.

The process to be followed in adopting the water service rates includes:

- 1. Hold a public hearing and receive testimony on the water rate and meter service charge increases for CSA 7.
- 2. After considering all written and oral objections to the water rates and meter service charges for CSA 7, close the public hearing and determine if there is a majority protest to the proposed water rates and meter service charges.
- 3. If there is a majority protest, terminate your consideration of imposing the water rate and meter service charge increases.
- 4. If there is not a successful majority protest, adopt the ordinance amending Sections 4.104.010 and 4.104.020 of Chapter 4.104 of Title 4, of the San Mateo County Ordinance Code, setting the water rates for FYs 2012-13 through 2014-15 for County Service Area No. 7
- 5. Adopt the Resolution authorizing the imposition of water service rates and meter service charges for FYs 2012-13 through 2014-15 beginning with the June billings for each fiscal year (June 2013, 2014, and 2015).

DISCUSSION:

CSA 7 provides quality drinking water in compliance with State and Federal Regulations to approximately 70 customers in the La Honda community. The Department provides staff to CSA 7 to perform routine operation and maintenance, 24-hour emergency response, billing and other administrative services, as well as, the purchase and installation of necessary equipment upgrades. The revenue to provide these services to CSA 7 customers is generated by water rates and meter service charges.

The January 29, 2013 Board Report (copy attached) explained the need for the water rates and meter service charges to be increased. Notices were sent to CSA 7 property owners and customers (approximately 128 mailing addresses), informing them of the proposed rate increases, the reason for the increases, and the time, place, and date when your Board would consider the proposed rates and charges. The purpose of the

public hearing is to allow your Board to hear and consider any objections and written protests of the proposed water rates and meter service charges.

Public Input Process

Department staff conducted meetings with the Committee to discuss proposed rates and revenue requirements to adequately support CSA 7 operations. The Department has also sent letters to all property owners and customers in CSA 7, provided information relative to the proposed water service rates, held a community meeting to discuss proposed rates, and sought their input regarding the proposed rates. No other viable alternatives were received as a result of the community meeting.

After the Board meeting on January 29, 2013, the Department sent a letter which provided property owners and customers with the proposed rates and information about the time and place of the public hearing. This notice complied with Article XIIIC and XIIID of the State Constitution (Proposition 218) by individually noticing each property owner and customer of record of the proposed water service increase and a mechanism for rejecting the proposed rates via a "majority protest" at the public hearing.

At the time this report was prepared, the Department had not received any written protests to the proposed water rates and meter service charges. We will report to your Board on any written protests that are received up to and including the date of the public hearing.

Alternates to Consider

After the close of the hearing, if there is not a majority protest, your Board can adopt the proposed water rates and meter service charges or reduce the water rates and meter service charges as you may determine appropriate. However, reducing the proposed rates would require identifying a source of funding, such as a loan, to support CSA 7 operations as the rates would not be sufficient to adequately support CSA 7 expenditures. Additional impacts to CSA 7 could include reduced maintenance; deferred capital improvements; or CSA 7 not meeting State and Federal water quality requirements that could result in possible fines against CSA 7.

The Department is recommending that the proposed rates be approved and be evaluated annually to determine their adequacy. Staff will continue to work with the Committee to evaluate the financial condition of CSA 7 and develop long-term rates that will be acceptable to the ratepayers while adequately meeting the financial obligations of CSA 7.

County Counsel has reviewed and approved an Ordinance and Resolution as to form, and we will provide an alternate form of resolution if there is a majority protest in CSA 7.

Your Board's adoption of the water rates and meter service charges contributes to the Shared Vision 2025 outcome of a Healthy Community by providing revenue to CSA 7 and allowing for uninterrupted potable water service to CSA 7 customers.

BACKGROUND:

On June 24, 1997, your Board adopted Ordinance No. 03781 adopting the water regulation and rates for County Service Area No. 7 (CSA 7).

On June 1, 1999, your Board adopted Ordinance No. 03909 adopting the current water rates and charges for CSA 7. The cost to operate and maintain the water treatment plant is shared between CSA 7 and the County's Probation Department for providing potable water to the Camp Glenwood Boys Ranch facility. Revenue generated from the residential customers with the current rates is not sufficient to adequately operate, maintain, and administer the CSA 7 water system and pay their share of the treatment costs.

DISCUSSION:

Public Input Process

Department staff have been meeting with the CSA 7 Customer Advisory Committee (Committee) since August 2011 to discuss the operation of CSA 7 and the need to increase water rates. These communications have taken place through letters,

Committee and public meetings, electronic mail, and telephone conversations. Staff has met with the Committee and provided them with detailed information regarding CSA 7 operations, regulatory requirements, budget information, and rate increase scenarios. Additionally, the Department sent letters to all property owners and customers of CSA 7 informing them of a public meeting held by the Department at the La Honda Fire Station the evening of December 11, 2012.

The Department's work with the Committee for the past several months has been focused on alternatives to major rate increases and considering different rate increase scenarios. The Committee members understand and agree that it is crucial to CSA 7's fiscal health that rate adjustments be for multiple years and be achieved before the end of this fiscal year. The Committee has, by majority vote, approved the Department's recommendation of a 66% increase during the 1st year after new rates are approved and a 33% increase in the 2nd and 3rd years to the water rate and meter service charges. The Committee also recommended that the Department focus on reducing expenses and develop a policy of periodic rate reviews to ensure CSA 7 achieves and maintains fiscal health.

In cooperation with the Committee, CSA 7 has implemented several cost saving measures which have included the installation of a remote monitoring and alarm system, shut-off valves, replacement of old meters, and enlisted the support of community volunteers in assisting with locating leaks, distribution of important information, and conducting customer outreach.

Acting as the Governing Board of County Service Area No. 7:

- Introduction of an Ordinance amending Sections 4.104.010 and 4.104.020 of A) Chapter 4.104 of Title 4, of the San Mateo County Ordinance Code, setting the water rates for FYs 2012-13 through 2014-15 for County Service Area No. 7 and waiver of reading the Ordinance in its entirety; and
- B) Adopt a Resolution setting Tuesday, March 26, 2013, at 9:00 a.m., at your regularly scheduled Board meeting, as time and place for a public hearing on the water rates and meter service charges for County Service Area No. 7.

BACKGROUND:

The La Honda water system was originally constructed in the 1920's to serve summer homes located near La Honda, Alpine and San Gregorio Creeks. The County acquired the system in conjunction with the acquisition of Sam McDonald Park in 1958, and formed County Service Area No. 7 (CSA 7) in 1965. CSA 7 was formed to provide potable water service to approximately 69 residential customers in the La Honda community within the boundaries of CSA 7 and to the County owned and operated Camp Glenwood Boys Ranch and Sam MacDonald Park located outside of the CSA 7 boundaries.

On June 24, 1997, your Board adopted Ordinance No. 03781 adopting the water regulations and rates for CSA 7. The Ordinance established a CSA 7 Customer Advisory Committee (Committee) to be an advisory group to the Director of Public Works and review future rate and operational changes proposed for CSA 7.

On June 1, 1999, your Board adopted Ordinance No. 03909 adopting the current water rates and charges for CSA 7. The cost to operate and maintain the water treatment plant is shared between CSA 7 and the County's Probation Department for providing potable water to the Camp Glenwood Boys Ranch facility. Revenue generated from the residential customers with the current rates is not sufficient to adequately operate, maintain, and administer the CSA 7 water system and pay their share of the treatment costs.

Your Board is being asked to take the following actions to set the water rates and meter service charges in CSA 7:

- 1. Amend the Ordinance Code to set the water rates and meter service charges for FY 2012-13 through FY 2014-15.
- 2. Set the second reading and adoption of Amended Ordinance for March 26, 2013.
- 3. Hold a public hearing and receive testimony on the water rate and meter service charge increases for CSA 7.
- 4. After considering all written and oral objections to the water rates and meter service charges for CSA 7, close the public hearing and determine if there is a majority protest to the proposed water rates and meter service charges.
- 5. If there is a majority protest, terminate your consideration of imposing the water rate and meter service charge increases and set the water rates and meter service charges for CSA 7 at the same levels currently in effect.

Article XIIIC and XIIID of the State Constitution (Proposition 218), requires notices be sent to property owners and tenants directly liable for payment alerting them of the public hearing to consider any new or increased property related fees, and a mechanism for rejecting the fees via a "majority protest" at the public hearing. We are recommending that your Board direct us to notify each affected property owner and customer in CSA 7 of the proposed water rates and meter service charges by mail and to explain that protests to the rates and meter charges must be in writing.

If there were a successful majority protest, the Board would be prevented from setting the water rates and meter service charges.

DISCUSSION:

Water Rates and Meter Service Charges

The most recent adjustments to the CSA 7 water rates and meter service charges were made in 1999. The current charges are comprised of a water rate charged per unit of water consumed (1 unit = 100 cubic feet or 748 gallons of water) and a monthly meter service charge. Customers are billed every three months or four times per year. Water billings are the only revenue source for CSA 7. The current water rate is \$4.80 per unit

of water and \$20.00 for the monthly meter service charge for a residential meter. The current and proposed water rates and meter service charges for CSA 7 are as follows:

The proposed rate increase is significant, but necessary to adequately support CSA 7. The average residential customer that uses 10 units of water per month currently pays \$68.00 per month, which is comprised of \$48.00 (10 units @ \$4.80) for water and \$20.00 for the monthly meter service charge. With the proposed rate increase the same customer using the same number of units of water per month would pay \$112.90, which is comprised of \$79.70 (10 units @ \$7.97) for water and \$33.20 for the monthly meter service charge. Without the substantial rate increase, the fund balance will be entirely exhausted by 2014. The significant factors influencing the need for a rate increase are summarized below.

CSA 7 System and Compliance

The County improved the system serving CSA 7, Camp Glenwood, and Sam McDonald Park by constructing a 500,000-gallon steel water storage tank in 1967 and a water treatment plant in 1993 to meet Federal and State regulations. A master plan was completed by Brown and Caldwell in 1998 for CSA 7, which recommended replacement of various sections of the distribution system with larger diameter pipes and repairs to the storage tanks and treatment plant. The source of water for the system is Alpine Creek. Water is pumped from the Creek, treated and delivered to customers through approximately 13,000 feet of water mains predominantly located in rugged terrain, including the Park, and varying in size from 3/4" to 4" in diameter.

The California Department of Public Health (DPH) assumed regulatory responsibility for small water systems from the County's Environmental Health Division on July 1, 2011. CSA 7's water system consist of old small diameter pipes throughout the system that do not supply adequate pressure to remote service areas and are prone to breaks that cause water service interruptions, which require customer notifications as mandated by the DPH.

As a result of the DPH's regulatory involvement, CSA 7 is required to perform specific water quality testing more frequently, implement an Operation and Maintenance Plan (Plan), provide 24 hour supervision by a certified operator during water treatment operations, complete a watershed sanitary survey, implement a cross connection control program, and make necessary improvements to the system to ensure

compliance with Federal and State regulations. These requirements have resulted in a substantial increase in staff time and contract services.

Your Board adopted Resolution No. 072210 on October 23, 2012, executing a three year agreement with Bracewell Engineering Inc. (Bracewell) for operation and maintenance services for County maintained small water and wastewater systems as it is not feasible for the Department staff to be certified operators. Bracewell had been providing certified operators to CSA 7 and CSA 11 since October of 2011, shortly after the Department's certified operator left County employment.

Public Input Process

Department staff have been meeting with the Committee since August 2011 to discuss the operation of CSA 7 and the need to increase water rates. These communications have taken place through letters, Committee and public meetings, electronic mail, and telephone conversations. In cooperation with the Committee, CSA 7 has implemented several cost saving measures which have included the installation of a remote monitoring and alarm system, shut-off valves, replacement of old meters, and enlisted the support of community volunteers in assisting with locating leaks, distribution of important information, and conducting customer outreach.

The San Mateo County Local Agency Formation Commission approved a Municipal Service Review and Sphere of Influence Update for CSA 7 (Update) at their November 16, 2011 meeting. The Update evaluated the CSA 7 past and current budget, included a water rate comparison, and discussed options for shared services. The Update recommended that CSA 7 proceed with a rate increase immediately.

The proposed water rates and meter service charges were communicated to the property owners and customers through a separate mailing by the Department. The

proposed water rates and meter service charges must support the following, at a minimum:

- 1. Continued routine and emergency operation and maintenance of the CSA 7 system per the requested Plan by DPH, including the preparation of the Plan.
- 2. Administration of CSA 7 to comply with reporting requirements, customer support, and customer billing.
- 3. Upgrades to raw and treated water storage tanks.
- 4. Upgrades and repairs to raw water intake and treatment plant equipment.
- 5. Minimum fund reserve to respond to emergency events.
- 6. Long term capital improvements, including the replacement of existing water mains, the completion and implementation of a cross connection control program and watershed sanitary survey, and addressing water pressure and water quality compliance issues.

The Department is recommending that the proposed rates be approved and be evaluated annually to determine their adequacy. We anticipate that the increased rates will encourage water conservation and revenue estimates have been based on a reduction in water use. It will be beneficial to review actual usage inclusive of winter and summer consumption patterns. Additionally, the Department intends to continue exploring options for maintaining the system that may be more cost effective while still complying with the requirements of the DPH.

We are proposing that the proposed rates increases be used to calculate charges beginning with the June billings for each fiscal year (June 2013, 2014, and 2015). The June billings will be based on water consumption during the approximate period of April through June of each year. Staff will continue to work with the Committee to evaluate the financial condition of CSA 7 and develop long-term rates that will be acceptable to the ratepayers while adequately meeting the financial obligations of CSA 7.

The water rates, meter service charges, and other associated CSA 7 charges are described in the Ordinance.

County Counsel has reviewed and approved the Ordinance and Resolution as to form.

Your Board's setting of the water service rates contributes to the Shared Vision 2025 outcome of a Healthy Community by providing revenue to CSA 7 and allowing for the continuation of service to CSA 7 customers.

A residential customer that uses 10 units of water per month currently pays \$68.00 per month and would pay \$112.90 per month with the proposed rates.

We estimate that it will cost approximately \$200 (\$3 per rate payer in CSA 7) to prepare, print and mail individual notices to each property owner and account holder in CSA 7. This cost will be paid from the revenue of CSA 7.

The proposed rates are anticipated to generate the additional revenues required to fund all routine and non-emergency operation and maintenance activities to meet current Federal and State regulations for FY 2012-13 through FY 2013-14 with small amounts for reserves and capital improvements. However, annual evaluations of the rates will need to be conducted to determine the adequacy of the rates. The proposed rates are not sufficient to fund all of the capital improvement projects recommended by the CSA 7 master plan.

There is no direct impact to the General Fund.
