Please refer to the ***San Mateo County Airports Policies and Procedures for Hangars, T-Shades, Tiedowns and Waiting Lists*** for a complete description of all standard hangar waiting list requirements and procedures. Individuals are required to provide/present the following to add their name to the Half Moon Bay Standard Hangar Waiting List:

- A copy of their Driver's License or photo ID indicating they are at least 18 years of age.
- A copy of their pilot's license or student pilot's certificate.
- Pay the non-refundable \$300 waiting list and administrative fee.

Qualifying applicants will be notified by mail when their name reaches the top of the list and a standard hangar is available. Applicants who do not respond or are unable to complete the required documentation described in the *San Mateo County Airports Policies and Procedures for Hangars, T-Shades, Tiedowns and Waiting Lists* within thirty (30) days of the date of the letter will be removed from the list and their waiting list fee forfeited. Applicants are encouraged to monitor their position on the list and be ready to provide the required documentation to accept the available hangar at the time it is offered.

PLEASE NOTE: Applicants are responsible for keeping their contact information current. If at any time an applicant cannot be contacted at the address provided, that applicant's name will be removed from the list and their waiting list fee forfeited. Individuals found to be in non-compliance with airport rules, regulations or other policies will not be eligible for a hangar. **By signature below, applicant acknowledges that they agree to the above requirements and have read and understand the *San Mateo County Airports Policies and Procedures for Hangars, T-Shades, Tiedowns and Waiting Lists*.**
