Review of Rating and Ranking Policy Approved by CoC	Focus Strategies and HSA staff provided an overview of the Project Review and Ranking Process policy (approved by the CoC Steering Committee on September 10, 2021), the role of the review panel, and aspects of the NOFO that impact scoring of projects.	
Review and Discussion of Renewal Project Scores	Twelve renewal project applications were received. HSA staff presented the scores for the renewal projects, which were calculated based on the 14 objective scoring factors in the Project Review and Ranking Process. The panel asked questions about scores but did not identify any needed adjustments. The panel discussed the grant management and spending for existing renewal applications, policy priority scoring, and COVID considerations in relation to project performance. A final rank order of renewals was determined, no renewal projects were re-allocated.	On 10/21/21, HSA will notify new and renewal applicants of
Discussion and Scoring of New Project	The panel members individually scored the four new project applications prior to today's meeting based on the 9 factors listed in the Project Review and Ranking Process. The four new applications include a new permanent supportive housing (PSH) bonus project from the Housing Authority, a rapid re-housing (RRH) bonus project from Community Overcoming Relationship Abuse (CORA), and two new transitional housing/rapid re-housing (TH/RRH) projects from Retraining the Village and Home and Hope.  The panel reviewed and discussed the need for each new project and the project quality as reflected in the application submitted and in relation to the scoring factors. The panel determined that the Housing Authority's PSH project and CORA's RRH project should be included in the Project Priority list but Retraining the Village and Home and Hope's TH/RRH project should not be included on the Project Priority List. The score for CORA's PRH project and the Housing Authority's PSH project were finalized. The panel also	their project ranking and whether or not their projects are included in the 2021 CoC Application.  Applicants have until 10/27/21 to file an appeal.
