San Mateo Local Agency Formation Commission Meeting January 16, 2019

6. Commissioner/Staff Reports

Executive Officer Poyatos said the Commission requested an update on the Health Care Districts' municipal service reviews, which would be on the Commission's March agenda. She said the Special District Selection Committee meeting was scheduled for February 12, 2019 for the position left vacant by Joe Sheridan's retirement. She said the draft policies on Government Code Section 56133 that would add the requirement for a deferred annexation agreement had been mailed to cities and districts requesting comments by February 19, and that a report would be on the March 20 agenda. She said outreach to cities and districts regarding the proposed policies that would include a city or district having adopted annexation plans would be started at a later date to avoid confusing the two issues. She noted that pending projects not ready for hearing include a proposal for the annexation of three parcels to the City of Belmont for a 250 multi-family rental unit development and the Commission would also be receiving a request from West Bay Sanitary District to divest their solid waste service for unincorporated areas including Ladera and unincorporated Menlo Park and transfer to the County of San Mateo in the coming months. She said during February and March the Budget Committee would begin work on the 2019-2020 LAFCo budget and the Legislative and Policy Committee would look at pending legislation and policy updates.
