I urge you all to attend and speak at the Planning Council meeting--each of you can talk about it from a different angle, and you should provide written copies of your statements to the Planning Council members.(5 for PC members + 5 for the planner, for Steve Monowitz if there, and the person running the hearing will need a few copies).

You could urge that the matter be tabled because you have not had adequate time to study the report and obtain information that might refute the report at the outset, or just make your presentations. The PC probably will not grant you a delay before hearing from you.

I think it's also important that if you have questions about the report and/or the developer's approach to things, you should ask those prior to the hearing or at the hearing if time does not permit before the hearing. These may help you get a delay. If you can create doubt, the Planning Council may also have the same questions after listening to you, and may ask the County to provide more information.

While the planner on this and his bosses may have all the information they think they need to make a recommendation; there may be something you can raise that would give them pause to table it until the next PC meeting.

Have to say that of all the arborists we've had to deal with, this one seems to be more honest than the rest, who simply do the bidding of the home owner or developer who hires them.
