On March 17, 2020, the Governor issued Executive Order N-29-20 suspending certain provisions of the Ralph M. Brown Act in order to allow for local legislative bodies to conduct their meetings telephonically or by other electronic means. Pursuant to the Shelter-in-Place Order issued by the San Mateo County Health Officer on March 16, 2020 and March 31, 2020, the statewide Shelter-in-Place Order issued by the Governor in Executive Order N-33-20 on March 19, 2020, and the CDC's social distancing guidelines which discourage large public gatherings, public hearings will not be held in person until the Shelter-in-Place Order is lifted. To be read into the record and discussed at the meeting, comments must be submitted via email no less than 30 minutes before the scheduled meeting. Comments received after that time will be held for the next scheduled meeting.

 - <u>Don Horsley</u>, San Mateo County Supervisor, joined the beginning of the meeting to welcome new members, thank all applicants for their enthusiastic interest in local agriculture, and also swore in new member Jonathan Winslow.
 - <u>Bill Cook</u>, Committee Member, shared about the recent celebration of life for Jim Reynolds, a cornerstone of the local community in Pescadero and the south coast.
 - Koren Widdel, San Mateo County Agricultural Commissioner, shared about the following:
 - The Department of Agriculture recently held a Grower's Workshop on Covid-19 with a panel of representatives from the Health Department and Cal-OSHA; the recording is available upon request to the Agriculture Department.
 - The Department of Agriculture has Covid-19 PPE including K-95 and surgical masks and hand sanitizers are available as well as coveralls and face shields for nonpesticide related applications available for farmers.
 - The Department of Agriculture is gathering community interest for a pesticide disposal event for production agriculture to get rid of old pesticides.

COMMITTEE ACTION:

The applicants provided a presentation to the committee about the project. The Committee discussed conducting a site visit and related logistics, past public meetings on the project site in 2021, Williamson Act versus Open Space protections for agricultural activity, the water sources for the agricultural ponds on the project site, and how the proposed lot line adjustments affect zoning, water, and related agricultural rules and regulations. The applicants invited small groups of interested committee members to conduct site visits before the next committee meeting.

Member of the public Ron Sturgeon raised several clarifying questions that drove discussions, including inquiring why the Williamson Act is being rescinded and replaced by an Open Space contract/easement for several proposed parcels; shared his desire to keep Williamson Act protections in place, which requires agricultural activity; and shared his desire for the committee to conduct a noticed, Brown Act compliant site visit as part of the consideration of this project. The applicant and planner shared points of clarification regarding the questions.

Member of the public Sandy Sommer shared that she is a consultant on the project and can help answer questions.

Member of the public Kerry Burke also raised several clarifying questions that drove discussions, including if the new/proposed parcel 3 meets the size requirements for the PAD and General Plan, if all new parcels created by lot line adjustments will be considered legal parcels, and if separate domestic water sources will be required for these new parcels. The applicant and planner shared points of clarification regarding the questions.

Committee Secretary Lauren Silberman moved, and Committee Member Fred Crowder seconded, a motion to table the rest of this discussion and all following items on the agenda to the meeting.

Motion passed 11-0-0, with no absent members.
